As a member of the Universities Superannuation Scheme (USS) or the NHS Pension Scheme, you may be aware that, in the last year or two, there have been significant changes to your pension scheme and the Government's approach to taxing pension savings. As a result, you may now find that, even from the 2016/17 tax year, you might now be liable to pay an unexpectedly large tax bill. Furthermore, there are strict deadlines on when these tax bills need to be settled with HMRC.

If you are a member of USS, you might also be concerned about how you can optimise the level of your retirement benefits, without encountering large tax bills, particularly if USS itself is changed again in the near future.
